**NOTICE OF ESTOPPEL AND STIPULATION OF CONSTITUTIONAL CHALLENGE TO ALL NEVADA STATE STATUTES WHERE No general law affecting private rights, shall be varied in any particular case, by special legislation, except with the free consent, in writing of all persons to be affected thereby; AND MOTION TO INTERVENE WITH AN INJUNCTION FOR NAME KEVIN FISHER dba FISHER KEVIN & NOTICE FISHER KEVIN d/b/a/ KEVIN FISHER registered agent for entity is Secretary of State of the State of Colorado as its agent upon whom a Notice of Claim against the public corporation may be served.**

**TAKE NOTICE THAT pursuant to 1764 NEVADA Constitution (as ratified without subsequent amendments) the BILL OF RIGHTS. NEVADA CONSTITUTION ARTICLE 1 DECLARATION OF RIGHTS, CA Constitution art I § 1. CA Constitution art I § 7, CA Constitution art IV, CA Constitution art IX**

SEC 1. All people are by nature free and independent and have inalienable rights. Among these are enjoying and defending life and liberty, acquiring, possessing, and protecting property, and (a) A person may not be deprived of life, liberty, or property without due process of law or denied equal protection of the laws.

SEC. 4 Free exercise and enjoyment of religion without discrimination or preference are guaranteed. This liberty of conscience does not excuse acts that are licentious or inconsistent with the peace or safety of the State. The Legislature shall make no law respecting an establishment of religion.

SEC. 9. A bill of attainder, ex post facto law, or law impairing the obligation of contracts may not be passed.

SEC.7 (a) A person may not be deprived of life, liberty, or property without due process of law or denied equal protection of the laws; provided, that nothing contained herein or elsewhere in this Constitution imposes upon the State of California or any public entity, board, or official any obligations or responsibilities which exceed those imposed by Equal Protection under the law.

**JURISDICTION**

Jurisdiction / Venue are hereby placed in one Supreme Court, pursuant to Article III Section 2 for The United States Republic, and the several States, under the Constitution; Article VI; and reaffirmed by obligatory Official Oaths.

“The Judicial Power shall extend to all cases, in law and equity, arising under this Constitution, the laws of the United States, and treaties made, or which shall be made, under their authority;--to all cases affecting ambassadors, other public ministers and consuls; --to all cases of admiralty and maritime jurisdictions;--to controversies to which the United States shall be a party;--to controversies between two or more states;--between a state and citizens of another state;--between citizens of different states;--between citizens of the same state claiming lands under grants of different states, and between a state, or the citizens thereof, and foreign states, citizens or subjects.”

In all cases affecting ambassadors, other public ministers and consuls, and those in which a state shall be a party, the Supreme Court shall have original jurisdiction. In all the other cases mentioned above, the Supreme Court shall have appellate jurisdiction, both as to law and fact, with such exceptions, and under such regulations as the Congress shall make.

**Elliot v. Peirsol, 26 U.S. 328,340 (1828) ("Courts are constituted by**

**authority, and they cannot act beyond the power delegated to them. If a court act without authority, its judgments and order are regarded as nullities. They are not voidable, but simply void; and form no bar to a remedy sought in opposition to them, even prior to a reversal. They constitute no Justification, and all person concerned in executing such judgments, or sentences, are considered, in law, as trespassers").** Legislative acts in violation of this Constitution, or the Constitution of the United States, **are void**, and the **Judiciary shall so declare them.**

**Article 8 -1. Indigenous peoples and individuals have the right not to be subjected to forced assimilation or destruction of their culture.**

**2. States shall provide effective mechanisms for prevention of, and redress for:**

**(a) Any action which has the aim or effect of depriving them of their integrity as distinct peoples, or of their cultural values or ethnic identities;**

**(b) Any action which has the aim or effect of dispossessing them of their lands, territories or resources;**

**(c) Any form of forced population transfer which has the aim or effect of violating or undermining any of their rights;**

**(d) Any form of forced assimilation or integration;**

**Article 9- Indigenous peoples and individuals have the right to belong to an indigenous community or nation, in accordance with the traditions and customs of the community or nation concerned.**

**No discrimination of any kind may arise from the exercise of such a right.**

**Article 10**

**Indigenous peoples shall not be forcibly removed from their lands or territories. No relocation shall take place without the free, prior and informed consent of the indigenous peoples concerned and after agreement on just and fair compensation and, where possible, with the option of return.**

3. Moorish American Peace & friendship Treaty Rights. I stand upon my square; I now invoke my Treaty rights. On and for the Record. I Kevin Fisher - El am a Moorish American National; kin by consanguine, it is on the public record that on September 10, 1952, in the Library of Congress Copyright Office, Washington, District of Columbia, and the United States Department of Justice released the right to the land.

4. My Moabite ancestors died intestate, and was vested with reversionary interest in the lands and resources of the Moroccan Empire at North America, which is in de facto occupational use, in usufruct, by the foreign hybrid European colonists exercising feudal law practices under color of
