Stare Decisis Law

"Courts are constituted by authority and they cannot act beyond the power delegated to them. If a court acts without authority, its judgments and orders are regarded as nullities. They are not voidable, but simply void; and form no bar to a remedy sought in opposition to them, even prior to a reversal. They constitute no justification; and all persons concerned in executing such judgments, or sentences, are considered, in law, as trespassers." See *Elliot v. Peirso*, 26 U.S. 328, 340 (1828)

On November 14, 2022, you were duly served with process at your mailing address the Affidavit of Fact: Writ of Quo Warranto [Exhibit: A] along with the Affidavit of Fact: Owner's Aboriginal Title to Allodium [Exhibit A1] Affidavit of Fact: Adverse Claim of and Reversion of Ancestral Estate [Exhibit: B] and Memorandum of Trust which was entered in the records of case number 22STUD02770 and was given three (3) days from that date to answer and prove your jurisdiction as of this date, you have failed to answer which constitutes default. It is therefore considered:

ORDERED AND ADJUDGED that this default judgment be and the same is hereby entered against you, Cherol J. Nellon, Wanyao Xuan, Michael c Earle (hereinafter "Judgment Debtors");

It is further ORDERED AND ADJUDGED that the Judgment Debtors are obligated to I, Malcom A. Bey (hereinafter "Judgment Creditor") for the following judgment:

- i. the immediate dismissal with prejudice of case number **22STUD02770** and any other attachments associated thereto for lack of jurisdiction and fraud; and
- ii. the total sum principal amount of \$3,022,000 payable in lawful money of .9999 fine silver bullion coins or bars for compensatory damages;
