Stare Decisis Law

"Courts are constituted by authority and they cannot act beyond the power delegated to them. If a court acts without authority, its judgments and orders are regarded as nullities. They are not voidable, but simply void; and form no bar to a remedy sought in opposition to them, even prior to a reversal. They constitute no justification; and all persons concerned in executing such judgments, or sentences, are considered, in law, as trespassers." See Elliot v. Peirsol, 26 U.S. 328, 340 (1828)

On March 18, 2022, you were duly served with process at your mailing address with the Affidavit of Fact: Writ of Error [Exhibit: D] which was entered in the records of case number GV22003334-00 and which ordered the collusive action and de facto administrative proceedings under color of law in such case, including the de facto administrative hearing held on April 1, 2022, being unconstitutional, notwithstanding, null and void ab initio for lack of jurisdiction and fraud. There was no cause to the contrary made by you or any other interested person(s) related.

Additional conclusive evidence of your lack of jurisdiction and fraud is shown in the records of related case number GV21018870-00, e.g., the unanswered Affidavit of Fact: Adverse Claim of Title and Reversion of Ancestral Estate [Exhibit: A1] entered in the case on December 16, 2021; the unanswered Affidavit of Fact: Writ of Quo Warranto [Exhibit: A] entered in the case on December 21, 2021; the unanswered Affidavit of Fact: Default Judgment [Exhibit: B] entered in the case on January 25, 2022; and the unanswered Affidavit of Fact: Writ of Error [Exhibit: C] entered in the case on February 1, 2022. As of this date, you have failed to execute your duty to dismiss with prejudice case number GV22003334-00 for lack of jurisdiction and fraud. It is therefore considered:

ORDERED AND ADJUDGED that this default judgment be and the same is hereby entered against you, Tina L. Snee, Susan Damara Madsen, Sang K. Park, and Jimmy C. Sohn (hereinafter "Judgment Debtors") and any other person(s) related thereto which may be amended to this judgment at a later date;

It is further **ORDERED AND ADJUDGED** that the Judgment Debtors are obligated to I, Keithel Bey (hereinafter "Judgment Creditor") for the following judgment:

- i. the immediate dismissal with prejudice of case number GV22003334-00 along with the misrepresented instrument – bill of attainder / foreign bill of exchange titled UNLAWFUL DETAINER ORDER dated April 1, 2022, any other attachments associated thereto for lack of jurisdiction and fraud; and
- ii. the total sum principal amount of \$3,022,000 payable in lawful money of .9999 fine silver bullion coins or bars for compensatory damages, and \$9,066,000 payable in lawful money of .9999 fine silver bullion coins or bars for punitive damages;

IT IS FURTHER ORDERED AND ADJUDGED that this default judgment shall serve as a judgment lien against the oaths of office, surety bonds, and all property (real and personal; corporeal and incorporeal) and assets of the Judgment Debtors as well as their spouse, heir(s), successor(s) and assign(s), in order to secure the performance of this judgment, and to levy on such property and assets for the satisfaction of this judgment if payment cannot be made;
