Stare Decisis Law

Elliot v. Peirsol, 26 U.S. 328, 340 (1828) ("Courts are constituted by authority, and they cannot act beyond the power delegated to them. If a court acts without authority, its judgments and orders are regarded as nullities. They are not voidable, but simply void; and form no bar to a remedy sought in opposition to them, even prior to a reversal. They constitute no justification; and all persons concerned in executing such judgments, or sentences, are considered, in law, as trespassers.").

MEMORANDUM

I am in receipt of your misrepresented instrument - bill of attainder/ foreign bill of exchange titled 7 DAY NOTICE TO PAY RENT OR QUIT NRS (40.253) Dated October 7, 2022. However, your instrument was issued under color of law within purview of the unconstitutional 14th Amendment due to your failure to prove jurisdiction and judicial authorization under Article III, sections 1 and 2 of the Constitution for the United States of North America. Therefore, your instrument titled 7 DAY NOTICE TO PAY RENT OR QUIT NRS (40.253) Dated October 7, 2022, and any attachment associated thereto are unconstitutional, notwithstanding, null and void ab initio and are not enforceable for lack of jurisdiction and fraud. See United States v. Throckmorton, 98 U.S. 61, 2S L.Ed. 93 ("Fraud vitiates the most solemn contracts, documents, and even judgments."); and see Elliot v. Peirsol, 26 U.S. 328,340 (1828) mentioned above.

On or about November 23rd, 2022, you were duly served with process at your mailing address with the Affidavit of Fact: Default Judgment [Exhibit: D] which was entered in the records of case number 22E038599, and which stands as conclusive evidence of your lack of jurisdiction and fraud.

WHEREFORE, it is considered ORDERED AND ADJUDGED that a writ of error be and the same is hereby entered against you, David F. Brown, Chris Alireza Karsaz. and Eric R. Newmark, and all other persons similarly situated that are involved and are not herein listed;

It is further ORDERED AND ADJUDGED that the misrepresented instrument – bill of attainder/ foreign bill of exchange titled 7 DAY NOTICE TO PAY RENT OR QUIT NRS (40.253) Dated October 7, 2022, and any attachments associated thereto are NULL and VOID AB INITIO and are UNENFORCEABLE for lack of jurisdiction and fraud;

It is further ORDERED AND ADJUDGED that the collusive action and de facto administrative proceedings in case number 22E038599 in the records of the foreign JUSTICE COURT LAS VEGAS TOWNSHIP (Inc.) CLARK COUNTY NEVADA (Inc.), including the de facto administrative hearing set for December 2nd, 2022, are UNCONSTITUTIONAL, NOTWITHSTANDING, NULL and VOID AB INITIO and are UNENFORCEABLE for lack of jurisdiction and fraud.
